




# General Fund Revenues Fiscal Years 2009 - 2012 (in \$ millions)





## General Fund Net Revenue Fiscal Years 2009 - 2012 Percentage Distribution by Revenue Source



## Consolidated Budget FY 2012










# General and Stabilization Fund Budget Fiscal Years 2009 - 2012 (In \$ millions)






# General Fund Budget by Legal Authority Fiscal Years 2009 - 2012 (In \$ millions)




# Stabilization Fund Fiscal Year 2010 - 2012 (In \$ millions)






# Consolidated Budget by Program Area Fiscal Year 2012 (In \$ millions)




# Consolidated Payroll Expenses Fiscal Years 2009 - 2012 (In \$ millions)



## Federal Grants FY 2009 - FY 2012


