Proposals will be evaluated and scored on the basis of the criteria set forth in the RFP. PRPHA has determined that the acceptance of a contract awarded under this solicitation precludes the acceptance of a contract under AVP-RFP-09-10-03. Moreover, contracts awarded under this solicitation shall be solely for one of the Six Areas where PRPHA is contracting management agent services.
